

International Petroleum Corporation Announces Results of Normal Course Issuer Bid

International Petroleum Corporation (IPC or the Corporation) (TSX, Nasdaq Stockholm: IPCO) is pleased to announce that IPC repurchased a total of 36,111 IPC common shares (ISIN: CA46016U1084) during the period of September 14 to 18, 2026 under IPC's previously announced normal course issuer bid / share repurchase program (NCIB).

IPC's NCIB, announced on December 3, 2025, is being implemented in accordance with the Market Abuse Regulation (EU) No 596/2014 (MAR) and Commission Delegated Regulation (EU) No 2016/1052 (Safe Harbour Regulation) and the applicable rules and policies of the Toronto Stock Exchange (TSX) and Nasdaq Stockholm and applicable Canadian and Swedish securities laws.

A summary and detailed breakdown of the transactions conducted on Nasdaq Stockholm during the period of September 14 to 18, 2026 according to article 5.3 of MAR and article 2.3 of the Safe Harbour Regulation is available with this press release on IPC's website: www.international-petroleum.com/news-and-media/press-releases. All share repurchases on Nasdaq Stockholm were carried out by Pareto Securities AB on behalf of IPC. All share repurchases on the TSX were carried out by ATB Securities Inc. on behalf of IPC.

All common shares repurchased by IPC under the NCIB will be cancelled. As at September 18, 2026, the total number of issued and outstanding IPC common shares is 112,159,304 with voting rights, of which IPC holds 283,138 common shares in treasury.

A total of 950,586 IPC common shares have been repurchased under the NCIB through the facilities of the TSX and Nasdaq Stockholm up to September 18, 2026. A maximum of 6,468,077 IPC common shares may be repurchased up to December 4, 2026, or until such earlier date as the NCIB is completed or terminated by IPC.

International Petroleum Corp. IPC is a member of the Lundin Group of Companies.
